

# ST. MARK CATHOLIC SCHOOL TUITION ASSISTANCE GUIDELINES 2025-2026

## **Guiding Principles - from the statement on Catholic schools by the USCCB**

#### Renewing Our Commitment to Catholic Elementary and Secondary Schools in the Third Millennium

Wherever possible, Catholic schools should remain available and accessible in all areas of a diocese for children who are from poor and middle-class families who face major economic challenges. In addition, Catholic schools should be available to students who are not Catholic and who wish to attend them. This has been a proud part of the history of Catholic schools in the nineteenth and twentieth centuries. We must continue this outreach in the new millennium.

#### St. Mark Catholic Parish Application of Guiding Principles

### **Objectives:**

- Ensure the school remains financially robust so it can responsibly and continuously serve its parish and school.
- Ensure families with limited income have access to a Catholic education.

## To ensure these objectives, the following principles will be followed:

- Tuition assistance is available for St. Mark students and is awarded, as funds are available, to those families with demonstrated need.
- Tuition assistance availability will be adjusted as required by school budgeting and fundraising realities. First consideration will be given to active St. Mark parish families in the granting of limited tuition assistance funds.
- In order to receive tuition assistance, a student must have been accepted into St. Mark School, and their family must be in good standing with the school. Admission and 'good standing' decisions are made by school administration annually.
- All families must contribute financially towards their children's education.
- Pre-K children are not eligible for tuition assistance.
- Emergency tuition assistance is available to families that experience sudden crises such as sudden job loss, emergencies due to illness or death, natural disasters, etc.



## **Tuition Assistance Process**

All tuition assistance is given on the basis of demonstrated need. In order to provide impartiality and fairness to our families, need is assessed by a third party provider, FACTS Grant and Aid Assessment. Only families who complete the FACTS evaluation process are eligible for tuition assistance. Awards are not renewable - families must re-apply every year.

All applications are strictly confidential. Applications are reviewed by a Tuition Assistance Committee. The group itself is anonymous and all information it reviews, financial or otherwise, is held in the strictest confidence. No information will be released to any other person unless required by law.

Applications for financial aid are accepted from January 10 to February 28. For 2025-2026, applicants are asked to submit their applications by February 28, and provide all required documentation no later than March 15. Award determinations are announced by the end of April. Since there are usually more families requesting assistance than there are available resources, submitting a late or incomplete application will unfavorably affect the likelihood and/or amount of an award.

The committee will only consider families whose financials has been verified by FACTS. FACTS will require copies of financial documents in order to verify an application. Families should work directly with FACTS to provide information in a timely fashion. On rare and unique instances where a family's situation makes it impossible for FACTS verification to occur, the committee reserves the right to grant a one-time exception as long as the situation merits the exception.

If a child's parents are divorced or separated, or do not reside in the same household, complete applications are required for each parent. This requirement may be waived by the Tuition Assistance committee in special circumstances, including when the whereabouts of a second parent is unknown, or a non-custodial parent is not supportive of Catholic education.

Once a family has submitted their information into the FACTS system, the Tuition Assistance Committee will ask for additional information, giving the family an opportunity to clarify their tuition assistance needs for the coming year, including any unique circumstances or details that provide clarity to the numbers in FACTS.



### Who May Apply

- Any current Saint Mark Catholic School (SMCS) family in good standing with the school.
- Any new family that has applied for admission at St. Mark. St. Mark has an "aid-blind" admission process.

### A family in good standing with the school is one who:

- Abides by the St. Mark School Handbook 'Parents as Partners' guidelines, including (but not limited to):
  - Supporting and cooperating with the discipline policy of the school.
  - Treating teachers, administrators and staff with respect and courtesy in discussing school issues. Refraining from divisive behaviors and propagating rumors.
  - Supporting the religious and educational goals of the school.
- Pays their share of tuition costs in a timely manner, and addresses any payment issues promptly with St. Mark School's business office.
- Has students who follow the St. Mark Catholic School Code of Conduct and who demonstrate consistent academic effort.

A family with significant issues in any of the above areas may have students attending St. Mark, but will not be eligible for the tuition assistance program. The pastor and the school principal will review the situation and make a final determination in this matter.

### **Amount of Assistance Awarded**

St. Mark has a limited amount of tuition assistance funds available each year. Tuition assistance award allocations are based on need as calculated by FACTS, additional financial clarifications provided by the family, and tuition assistance fund availability. Families must commit to paying a minimum of 20% of total tuition. Families whose income would make them eligible for free and reduced lunch must commit to paying a minimum of 10% of total tuition.

#### **Emergency Tuition Assistance**

Emergency tuition assistance subsidies may be awarded to families that experience unexpected hardship during a school year. The family needs to follow the regular FACTS tuition assistance application process. Emergency tuition assistance subsidies can be applied for at any time. In this case, the pastor and school principal can provide waivers of the minimum tuition contribution requirements.

#### Final Confirmation of Tuition Assistance Award

In order to finalize the tuition assistance award amount, a family must complete the school's registration process, including payment of a registration fee (a portion of the fee may be waived by the tuition assistance committee), and submit a complete Tuition Agreement Form by the deadlines noted in St. Mark's registration materials. Funds allocated to students who do not register on time will be awarded to other needy students.
