### **Active Catholic Stewardship Application 2026-2027 School Year**

The Catholic Steward Tuition Rate is designed to support Catholic families in our parish community through a tuition discount. Catholic Steward families are those who are dedicated to raising their children in the Catholic faith and are active in the parish community. Active families attend Sunday Mass regularly and serve in the community through the gifts of time, talent, and treasure. Children must be up-to-date on Sacraments

#### Criteria to meet in order to receive the St. Mark Catholic Steward Rate are:

**Registered:** You *must* have been registered in the Parish for at least 3 months. If you have recently moved or are moving to the area, you must provide a letter from your previous parish stating that you are actively living stewardship through time, talent, and treasure.

**Active:** Active parishioners should be *regularly* attending Mass and volunteering their time and talent with a St. Mark ministry. Ministries include but are not limited to: altar servers, ushers, greeters, EMHC, lectors, etc.

**Contributors:** Contributors are those who are giving a minimum of \$1000 per year to the church offertory in the form of *identifiable* gifts by envelope, check, or online giving (direct, stock proceeds, donor-advised to any Parish Capital Campaign (non-BAA) will also be considered when evaluating an applicant's contribution). Please remember, it is through the generosity of the parish that the school is able to offer a substantial discount rate to our Catholic Families, who demonstrate their prayerful, sacrificial giving to the church. We encourage contributions to the School Annual Fund, but they do not replace the regular financial support of the Parish.

#### **Active Catholic Steward Tuition Rate Process**

- Forms are collected in the Admissions office, either via FACTS SIS, mail, or Fax.
  - o **Non-parishioners** must submit an Active Catholic Steward Form signed by their Pastor
- The data will be privately collected and evaluated
- After review, you will be notified of the tuition rate
